Empty Rates Relief: I am sure I read a paper on Christmas Eve, but have temporarily mislaid it, which will be good news for those with empty properties as I am certain the government announced at the very tail end of last year that they are extending the Empty Property Rates Relief Scheme by a further twelve months from 1st April and increasing the rateable value from which it now applies from £15,000 to £18,000. This does not necessarily mean there will be more properties in the scheme for the new rateable values will come into effect on the 1st April, but it will be a relief I am sure for many who currently have small commercial properties sitting empty unable to be let at any price. Another government document was produced in December which might be of interest which was Planning Policy Statement 25 : Development and Flood Risk Practice Guide. For those people who think they may have seen this before it is dated December 2009. I can only assume that this has the approval of the RICS and the Law Society as I see it has been prepared by a very well respected firm of solicitors on behalf of the Communities and Local Government Department. STOP PRESS.....LATEST NEWS.....Published 29th December 2009 : Don't let anyone tell you we haven't been working for you over the Christmas break.....The government published last Tuesday (yes the day after Boxing Day) a very important planning document. " **Planning Policy Statement 4 (PPS4) sets out the Government's comprehensive policy framework for planning for sustainable economic development in urban and rural areas.**" and replaces various Guidance Notes going back nearly 18 years.
